

## **Real Estate Information Form**

The Burbank-Glendale-Pasadena Airport Authority, owner and operator of the Hollywood Burbank Airport, would like to inform prospective property buyers:

- 1. Of the location of the Hollywood Burbank Airport in their community
- 2. That their property might be impacted by aircraft operations

Hollywood Burbank Airport operates 24 hours per day and currently serves approximately 5.2 million revenue passengers annually. The airport has approximately 360 daily flight operations (arrivals + departures) that are divided by percentage roughly "40/60" between scheduled airlines and non-scheduled general aviation aircraft. General aviation includes, but is not limited to, private propeller aircraft, business jets, cargo aircraft, charters and the military. Depicted is the most recently submitted Quarterly Noise Report for the 65 dB Community Noise Equivalent Level (CNEL) contour as required by the County of Los Angeles. Homes located outside the contour area may still experience an impact of aircraft operations. For questions regarding airport or aircraft operations, please call 818-840-8840.

- 3. Figures are calculated from 2<sup>nd</sup> Quarter 2020.
- 4. Quarterly contours are subject to change.

In 2013 the Federal Aviation Administration approved the Hollywood Burbank Airport's updated Part 150 Noise Exposure Map, this Part 150 Study can be found at the Airport's website, <a href="http://hollywoodburbankairport.com/noise-issues/part-150-study-updates/">http://hollywoodburbankairport.com/noise-issues/part-150-study-updates/</a>. In June 2018, the FAA recertified the existing operation & passenger forecast through 2022. As a result of this approval, a number of single-family homes surrounding the Airport are eligible for acoustical treatment.
