### **AIRPORT AUTHORITY COMMISSION ELECTS GLENDALE COMMISSIONER ZAREH SINANYAN AS PRESIDENT FOR THE COMING YEAR**

*Burbank Commissioner Ray Adams Chosen as Vice President;  
Pasadena Commissioner Ross Selvidge, Ph.D. Named Secretary*

BURBANK, Calif., July 16, 2018 – The Burbank-Glendale-Pasadena Airport Authority, owner and operator of Hollywood Burbank Airport, has elected new officers to head the Authority Commission for a one-year term from July 2018 through June 2019. The Commission elects officers each July.

Glendale Commissioner Zareh Sinanyan was elected President, Commissioner Ray Adams of Burbank was elected Vice President, and Commissioner Ross Selvidge of Pasadena was chosen Secretary.

Sinanyan, also the current Mayor of Glendale, was first appointed to the Airport Authority in May 2015, and served as Vice President this last term and Secretary the previous term. Ray Adams was first appointed to the Commission in May 2015, and served as Secretary this last term. Selvidge was first appointed to the Commission in February 2015, and served as Treasurer this previous term.

In related actions, the Authority appointed Glendale Commissioner Vartan Gharpetian as Treasurer, appointed Burbank Commissioner Bill Wiggins as Auditor, and reappointed Executive Director Frank Miller as Assistant Secretary.

The Burbank-Glendale-Pasadena Airport Authority is a joint powers agency formed by the three cities to own and operate Hollywood Burbank Airport. The Airport Authority is governed by a nine-member Commission, and each of the three cities appoints three Commissioners.

In addition to the officers, the other current Commissioners are: Don Brown of Burbank; Paula Devine of Glendale; and Terry Tornek and Steve Madison of Pasadena.
